Complete Spinal Cord Injuries

Occurs when the spinal cord is fully compressed or severed, completely eliminating the brain's ability to send signals below the point of injury. (Therefore no muscle tone below the point of injury).

Incomplete Spinal Cord Injuries

Occurs when spinal cord is compressed or injured, but the brain's ability to send signals below the site of injury is not completely removed. (Therefore they may have muscle function and tone below the point of injury).
